**A RESOLUTION TO ADOPT INCREASED TAP FEES EFFECTIVE
JANUARY 1, 2022**

WHEREAS, The Board of Directors has determined that it is necessary to increase revenues to cover budgeted current year expenditures and future expenditures, and

WHEREAS, the Board held a public meeting on November 18, 2021 to discuss the proposed changes to the water and wastewater tap fee structures, and


WHEREAS, posting of the meeting was made thirty days in advance, in accordance with state statutes governing the right of those to be impacted to have input into the discussion. The District also included notice of the meeting on its website, and

WHEREAS, the District has fiduciary responsibility to manage the District prudently and is authorized by various statutes to change fees and charges for services as the Board determines to be in the best interests of the District, it's rate payers and bond holders.

ROUND MOUNTAIN WATER AND SANITATION DISTRICT, COLORADO THAT:**


Fee changes be adopted to Appendix A of the District's Rules and Regulations, "Water and Wastewater Tap fees" as attached to this resolution.

SYSTEM DEVELOPMENT FEES AND CONNECTION CHARGES FOR TAPS WITH POLLUTANT LOADINGS OVER 1 ERU WILL BE DETERMINED BY THE BOARD OF DIRECTORS

DISTRICT TECHNICIANS WILL INSTALL THE WATER AND SEWER TAPS ONCE THE OWNER EXPOSES THE MAINS.

THE OWNER IS RESPONSIBLE FOR ALL OTHER EXPENSES AND REQUIREMENTS FOR INSTALLING WATER AND SEWER SERVICE LINES INCLUDING MATERIALS, EXCAVATION, INSTALLATION, BEDDINGS AND BACKFILLING.

PROPERTIES WITH PRE-EXISTING WATER AND SEWER STUB-INS WILL NOT BE REQUIRED TO PAY THE TAPPING FEE.

CERTAIN PROPERTIES WITHIN THE DISTRICT ARE SUBJECT TO WATER AND SEWER EXTENSION REBATE AGREEMENTS. THESE PROPERTIES SHALL PAY AN ADDITIONAL MAIN INSTALLATION REIMBURSEMENT FEE AS DESCRIBED IN THE REBATE AGREEMENT WHEN PURCHASING TAPS.
