A RESOLUTION TO ADOPT THE 2005 SOURCE WATER PROTECTION PLAN.

WHEREAS, Round Mountain Water and Sanitation District participated in a Source Water Assessment and Protection Program in 2004 to define existing and potential potable water contamination risks, and;

WHEREAS, a steering committee was formed to address concerns presented by the Source Water Assessments and completed a Source Water Protection Plan in 2005, and;

WHEREAS, Round Mountain Water and Sanitation District desires to implement and enforce specific protection measures developed in the Source Water Protection Plan to secure the quality and availability of drinking water now and into the future.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ROUND MOUNTAIN WATER AND SANITATION DISTRICT, COLORADO:

To adopt, implement and enforce the Source Water Protection Plan by authorizing District employees to solicit partnership and cooperation with the Town of Westcliffe, the Town of Silver Cliff and Custer County to establish and enforce new rules and regulations that protect our community's drinking water sources. The Board of Directors also directs District employees to recommend changes to the District's Rules and Regulations to enforce the Source Water Protection Plan.

RESOLUTION NO. 17-06

A RESOLUTION ADOPTING THE SOURCE WATER PROTECTION PLAN APPROVED AND ADOPTED BY THE BOARD OF DIRECTORS OF THE ROUND MOUNTAIN WATER AND SANITATION DISTRICT ON MARCH 16, 2017

Whereas, on March 16, 2017, the Board of Directors of the Round Mountain Water and Sanitation District (RMWSD) approved and signed a Resolution formally adopting a document known as the Source Water Protection Plan (SWPP). The purpose of the SWPP is to ensure the quality and the availability of potable drinking water provided by RMWSD to its customers. A copy of said SWPP is attached to this Resolution and its contents are incorporated herein as if set forth verbatim in this Resolution.

Whereas, the RMWSD owns and operates a well commonly known as the Gallery Well, as explained in the SWPP. The Board of Directors of the RMWSD has requested that the Board of County Commissioners for Custer County adopt a county resolution supporting the implementation and enforcement of the Source Water Protection Plan, and has specifically requested the establishment of a 1000-foot buffer zone surrounding the Gallery Well wellhead; and

Whereas, the Board of County Commissioners for Custer County, a political subdivision of the State of Colorado, has considered the request and finds that support of the Source Water Protection Plan would serve to protect the health, safety and welfare of the citizens of Custer County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners for Custer County that the County should and hereby does declare its support for the Source Water Protection Plan approved and adopted by the Round Mountain Water and Sanitation District on March 16, 2017, and in furtherance of this statement of support declares that there shall be

established a buffer zone with a radius of 1000 feet in all directions from the wellhead of the Gallery Well, in which said buffer zone no onsite wastewater treatment systems shall be permitted; and

BE IT FURTHER RESOLVED THAT any property in the unincorporated portions of Custer County that is located within 400 feet of any existing Round Mountain Water and Sanitation District infrastructure shall be required to connect to RMWSD water and wastewater utilities, except this requirement shall not apply to wells and wastewater treatment systems that may be in existence as of the effective date of this Resolution.
