1. SGM Presentation

The perk test results were better than expected, but they are still waiting for the permeability results in the final report. It may take up to 6 months to get the PEL's and they are not sure when the State will come up with the new TMDL's. SGM can't design a treatment plant without the required data numbers. The Board was told that as frustrating as all the delays are, it's better to wait and design a plant that won't be obsolete in a few years.

2. 2019 Pricing for Town Parks

The original plan was to use grant money to pay for a rate study. Right now, the government is shut down and there is no one to talk to about funds. The Board needs to decide when they would like to go public and give 30 days' notice. Manager Medaris will check with Florence to see how their rate study is going, and who's doing the study.

3. Discussion of DeWeese Reservoir Engineering Proposal

Managers Medaris and Schneider will attend a meeting at Brookside on January 18th, regarding a proposal for increasing the storage capacity in Lake DeWeese.

4. Discussion of Upper Ark Augmentation Filing

On January 24^{th,} George Medaris and Dave Schneider will meet with Terry Scanga and Chelsey Nutter to discuss how the proposed augmentation plan can benefit Custer County and how Round Mountain and Upper Ark can work together. Manager Medaris is recommending that RMWSD's water attorney and water engineer be hired to protect our interests and file opposition. Peggy Quint made a motion to hire Krassa & Kroeker to file opposition. Greg Smith seconded the motion. Motion passed 5-0.
